November 11, 2024

A worksession meeting of the Washington School Board was held on Monday, November 11, 2024 in the high school cafeteria.

The meeting was called to order by President Sparks-Gatling at 6:35 pm, followed by the pledge of allegiance and the district's mission and audio/video recording statements.

Mrs. Barnes moved and Mrs. Roberts seconded that the Board approve the following:

- -Recommend **James Wilson** as Custodial and Maintenance Supervisor. (*This is a contracted position.*)
- -Recommend **Robert Anderson** as a full-time paraprofessional, 186 days a year, 7 hours a day, contractual rate, effective November 12, 2024.

- -Intermittent Family Medical Leave for **Employee #1258**, retroactive to October 22, 2024. (*Per the Family and Medical Leave Act and District Policy No. 410*, eligible employees are entitled to take up to 60 unpaid days during a 12-month period for the specific type of FMLA leave requested by this employee.)
- -Conference requests, in accordance with the policy of the District as follows:

- -Extension of the Direct Energy Consortium Agreement for the purchase of natural gas through AIU for a three (3) year period, starting in September 2025.

-Results from water testing – Water samples were collected on October 11<sup>th</sup> from various locations in the high school, elementary school and central office. All of the results passed the Pennsylvania DEP standards for safe drinking water for lead, which is less than 0.015 mg/L.

He will be meeting with AMI next week to see what services they can provide for our students. He also reported on partnering with WQED to provide materials needed for our students. Washington Financial Bank has committed to a financial gift to support our students' need for coats and other items. United Way is also helping our students. He thanked the high school nurse, Ashley Brand, for collaborating with these organizations to help support our students.
